Other Conditions: Any change in ownership of berth will require a transfer fee of \$100. For a horse to be eligible to run in the trials it must be owned or leased by berth owner at time horse is named.

Oklahoma Bred awards paid to 1st-5th place in the Derby: 45%, 25%, 15%, 10%, 5%

IF A PAYMENT IS MISSED, THAT PAYMENT MUST BE DOUBLED TO REMAIN ELIGIBLE. Finalists shall be selected by taking the 10 fastest times. If, for any reason, a tie exists, the horses involved shall draw lots to determine which shall participate in the race. The interest, 12% of the subscription purse will be deducted for operating, promotion, advertising, administration and accounting. OHA reserves the right to reschedule, move, or cancel this race for any reason deemed good or sufficient.

**Subject to OHRC approval*

It is the responsibility of the owner and/or trainer to make sure their entry is duly registered and eligible by meeting all conditions as published. Should a horse be ineligible and scratched, all fees paid in will be forfeited to the purse and not subject to refund. By making entry into this race I agree to abide by the rules and regulations as published by the OHA, OHRC, Will Rogers Downs and enforced by the Board of Stewards and to accept their decision as final.
