REMINDER: DOUBLE ENTRIES EACH THURSDAY FOR THE FOLLOWING MONDAY AND TUESDAY. ENTRIES FOR BOTH DAYS ARE TAKEN SIMULTANEOUSLY AND A FINAL FOR BOTH DAYS WILL BE CALLED AT ONCE WHEN SUFFICIENT ENTRIES HAVE BEEN TAKEN. EXTRAS OFFERED ON THE SUNDAY OVERNIGHT MAY BE USED EITHER MONDAY OR TUESDAY. AGENTS SHOULD MAKE ALL ENTRIES BY 10:00AM. Thank you.

OWNERS SILKS MUST BE REGISTERED PRIOR TO THE PROGRAM GOING FINAL AND BROUGHT FIRST TO THE CLERK OF THE COURSE. DO NOT BRING SILKS TO THE JOCKEYS ROOM. JOCKEYS WILL LEAVE THE ROOM WEARING WHAT IS LISTED IN THE PROGRAM. PLEASE WAIT UNTIL AFTER THE LAST RACE TO REQUEST ANY SILKS BACK FROM THE ROOM. Thank you for your cooperation.

Weather permitting, morning training hours are 7:00 - 10:00am, gates from 7:30 - 9:30am, dark Wednesday, no gates Thursday. There is no training on the training track unless the main track is closed and EMTs are present. PLEASE BE CLEAR WHEN TAKING HORSES TO THE GATE ABOUT THEIR NAME AND IF THEY ARE STANDING FOR THE PURPOSE OF COMING OFF A LIST. Thank you for your cooperation.

ATTENTION TRAINERS: Please check the past performances (available in the racing office) on entry days to ensure that your horses have been entered properly. Corrections can be made before going final.

Mandatory race-day veterinary inspections will begin at 7:00am at Barn D. Trainers with assigned stalls must have horses in place at that time. In-today horses hauling in must be on the grounds by 10:00am and in the appropriately assigned location for inspection. Trainers that plan to ship into a barn other than the haul-in barns must plan with the stall superintendent on the day of entry. Inspected horses must remain on the grounds until after the race.

To obtain an official workout time at WRD, it is mandatory to complete and submit workout cards. Please pick up workout cards ahead of time from the racing office, clocker, or gap attendant. Thank you for your cooperation.

Horsemen wishing to haul in for workouts on race days or arrive with horses that are not "In-Today" are to contact (918) 633-2463 in advance for accommodations or stall space. Trainers must obtain approval before occupying the haul-in barns with horses that are not designated as "In-Today". Trainers should be prepared to work-and-go. Thank you for your cooperation.

PADDOCK TARDINESS AFFECTS EVERYONE AND IS UNACCEPTABLE. PLEASE PREPARE RESPONSIBLY AND ARRIVE TO SADDLE PROMPTLY. TRAINERS ARE TO TAKE RESPONSIBILITY FOR THE SADDLING OF THEIR OWN HORSES, OR REPORT TO THE STEWARDS IN THE EVENT AN ASSISTANT OR PROXY IS TO BE USED.

Pony horses may enter the saddling paddock only with prior approval from the paddock judge and are not permitted inside the Winners' Circle. Thank you for your cooperation.

Vehicles on the backstretch must always yield to horses - no exceptions. There is no parking on the roadway between barns on race days. Also, help us keep the backside roads intact by minding the 15 MPH speed limit. Thank you for your cooperation.
