RACE CONDITIONS:

- ELIGIBLE HORSES:** Only Quarter Horse foals of 2020 which are registered with the American Quarter Horse Association and sired by Black Gold Program Sires are eligible to enter these races.
- An owner may nominate as many horses as desired. If one or more nominations are withdrawn prior to the actual running of the race, it is the owner's responsibility to specify which horses are being withdrawn when making payments. Nominations or subscriptions may be refused or canceled, without liability at any time prior to the actual running thereof, except for the return of any nomination, sustaining and entry fees paid. All payments must be postmarked no later than the dates due and should be sent by certified mail. **THE SENDER'S RECEIPT MUST BE PRESENTED AS PROOF OF PAYMENT SHOULD ANY DISCREPANCY OCCUR.** All checks returned by the bank will constitute no payment. All payments for Futurity races shall be remitted to and collected by the race sponsor.
- PAYMENTS:** In the event a sustaining payment is late (the "Late Payment"), eligibility of the nominated horse, will not be terminated if on or before the due date of the next immediate sustaining payment (or the entry date if the Late Payment is the last sustaining payment), the person nominating the Eligible Horse pays (a) such next sustaining payment; (b) the Late Payment; and an additional amount equal to the Late Payment. The foregoing provision will not apply to consecutive sustaining payments. Payments shall be sent to: Oklahoma Quarter Horse Racing Association P.O. Box 2907 – Edmond, OK 73083.
- ESTIMATED PURSES:** The total purse for each Championship will be determined by combining all nomination and sustaining payments for each particular race less 15% deduction for administrative and advertising expense, and plus \$12,500 per race added from Horsemen's Purse Account as well as \$20,000 per race in Stallion Funds for 2022, and an additional amount of \$100,000 per race added from the Oklahoma Tribal Purse Fund. 5% will be deducted from each Championship purse and paid as Stallion Awards. Stallion awards will pay 10 places in each Championship. All 2021 Black Gold Races will be conducted during the 2021 Will Rogers Downs Quarter Horse Mixed Meet, PURSE DISTRIBUTION: 40%, 17%, 11%, 9%, 7%, 5%, 4%, 3%, 2%, 2% Credit card payments will be subject to 3.5% convenience fee. Stallion rewards will be distributed in same ratio as purse money.
- ENTRY:** Entries in both races must be made through the entry box at Will Rogers Downs by closing time for entries in that race. Prior to racing, an owner is required to have on deposit with the Horsemen's Bookkeeper the amount required to cover all costs of starting a horse, including minimum jock mount for trial races if required by the Racetrack conducting the races.
- TIME TRIALS:** In the time trials, horses shall qualify on the basis of time and order of finish. The times of the horses in time trials will be determined only to the limit of the timer, the only exception is when two or more horses have the same exact time in the same trial heat. Then the order of finish shall also determine the preference in qualifying or the finals. Should two or more trial contestants have the same qualifying time to the limit of the electronic timer for the final qualifying position or positions, then draw by random lot shall be conducted as directed by the board of stewards. Except in the case of a disqualification, under no circumstances shall a horse qualify ahead of a horse that finished ahead of that horse in the official order of finish. Should a horse be disqualified for interference during the running of a time trial, it shall receive the time of the horse it is immediately placed behind plus one hundredth (1/100) of a second, or to the maximum accuracy of the electronic timing device. No adjustments shall be made in the times recorded in the time trials to account for head wind, tail wind, off track, etc. In the event of a timer malfunction for a trial race, the Stewards will use the technological aid of video frame by frame analysis to assign times to each participating horse in that trial. The ten fastest times in trials will advance to finals. In the event twelve (12) horses or less are eligible to run in the trials, only a Final may be run. The Final may be run either on the regularly scheduled trial day or Final day at the discretion of the management and /or the race sponsor if applicable. There will be no also eligible list for trials or finals. If one or more horses scratch from the Finals, the owner (s) of scratched horses will receive last place purse money, and the remaining purse money shall be distributed proportionately to the horses running in the Finals.
- SCRATCHES:** If a horse is ruled ineligible by the stewards or the Oklahoma Horse Racing Commission for entry into any of the races or if the stewards scratch or disqualify a horse from any race described herein for a race violation, such horse will be ineligible for receipt of any purse money. After the entry date for the finals, the purse money that might have been due to such horse will be divided proportionately (based on purse percentages) among the other starters in such race. If, after the entry date for such race, one or more horses are withdrawn from the final for any reason other than ineligibility or a rule violation, the purse monies (in inverse order of finish) equal to the number of withdrawn horses for such race will be distributed equally to the owners of the horses withdrawn from such final. If, prior to the entry date for the final a horse is ruled ineligible for the final as provided above; the next eligible horse may be entered in such race.
- SUBSTANCE TESTING:** As a condition for participation in this race, all horses nominated to OQHRA administered futurities or derbies will be subject to substance testing. In addition to the pre-entry hair testing requirement by Will Rogers Downs, every entry for the trials in this race will be required to have a negative hair test for prohibited substances in accordance with the same pre-entry hair test requirements implemented by Will Rogers Downs that was collected within 45 days of the trials for this race. Additionally the owner of the top 15 qualifiers for this race, based on the trial times, agree that they MAY be required to provide a negative hair test for prohibited substances, in accordance with the same pre-entry hair test requirements implemented by Will Rogers Downs, after the trials and before the final for this race. A positive report for any prohibited substance will result in loss of eligibility to participate in trials or finals.

By submitting a signed nomination form for this race, the undersigned, by or on behalf of the owner of the nominated horse, the owner's agents and representatives, and the owner's heirs and assigns (including any future owner of the nominated horse) agrees to be subject to and abide by the results of the initial (commonly referred to as the "sample A test") hair testing of the nominated horse and voluntarily and irrevocably waives the following:

- A. Any and all rights to have a secondary or split sample tested
- B. Any and all rights to a hearing (whether formal, informal, by written submission or in person) to contest the results of the initial test or resulting denial of entry in the race, whether a qualifying race or final race.
- C. Any and all rights to contest under any circumstances or grounds, the results of the initial test or the resulting denial of entry in the race, whether a qualifying race or final race.
- D. Any and all rights to challenge the results of the initial test or resulting denial of entry in the race, whether a qualifying race or final race, directly or indirectly, before any court or other tribunal; and
- E. By their entry into the race, all participants irrevocably waive any legal claim they might have against OQHRA and/or Will Rogers Downs, its officers, executive committee members, or its employees arising from or related to the hair testing which is the subject of this paragraph.
- F. A report of the result of an un-official test submitted as a requirement of eligibility for entry is not admissible for any purpose in any OHRC proceeding arising from a positive report of an official test administered by OHRC.

Test results will be reported to the host track officials and notification of positives will be sent to the trainer of the nominated horse. OQHRA will send a list to the racing office of the host race track for the specific race(s) to notify them of horses that are eligible to enter races based on the results of their tests.

- 9. If the front gates or the starting gate fail to open due to mechanical failure, or if a horse is left behind the gate when the field is dispatched during the running of the Trials, such horse may be declared non-starter and the stewards may determine that owner is entitled a refund of all nominating, sustaining and entry fees but not including administrative and advertising fees deducted from gross purse with a subsequent revision in the final purse distribution to reflect the refunded amount. During the running of a Finals such horse may be declared a non-starter and shall be classified as a scratched horse and shall be paid last place purse money in the race.
- 10. Racetrack management (with approval of race sponsor if applicable) or the races sponsor, and the OHRC may change the running date of Trials and Finals. All races described herein may be cancelled, rescheduled, or relocated, or revise the conditions at any time prior to the actual running thereof, without liability, except for the return of nomination and sustaining fees paid if cancelled.
- 11. Eligibility for a stakes race does not guarantee a stall assignment for the entire meet. No entry will be received and no stabling will be permitted except upon the conditions that all disputes, claims, and objections arising out of racing or with respect to interpretations of any rules, conditions of races, or otherwise shall be decided by the Oklahoma Horse Racing Commission, the Stewards, the Racetrack Management, or the race sponsor and such decision upon all points shall be final. All horses, either by the time or performances; which do not meet OHRC or Racetrack Eligibility Rules, will be ineligible.
- 12. Race sponsor is Oklahoma Quarter Horse Racing Association. All disputes as to eligibility to participate in the race will be determined in the sole discretion of OQHRA and the decision of OQHRA will be absolute, final and binding.
- 13. Final schedule for trial dates and running of the final to be determined upon approval of the OHRC 2022 racing license for Will Rogers Downs.
