STALL SPACE APPLICATION

TERMS & CONDITIONS

As a condition of the acceptance of this application, it is mutually agreed and understood that application ("Applicant") and all person for whom he/she is acting will be bound by the terms and condition of this stall application as set forth below and the Applicant represents that he/she has been granted the appropriate authority by all owners of the horse in the care of the Applicant, to make this application and to agree to its terms and conditions, to bid such owner(s) to the same.

1. Fair Meadows at Expo Square ("Racetrack") reserves the right to refuse the application for stable space in whole or in part or refuse the acceptance of any entry into any race for any reason or cause and without notice to the undersigned.
2. All disputes, claims and publications arising out of the racing or with respect to the interpretation of any rules or conditions or races of otherwise, shall be decided by the Oklahoma Horse Racing Commission ("OHRC"), the Stewards of the meeting or Racetrack Management as the case may be, and such decisions upon all points shall be final.
3. **Stabling Qualifications:** The following horses will not be eligible for stabling at Racetrack:
 - A. Horses that have never won two races lifetime and have started for a claiming price of \$3,000 or less.
 - B. Maidens that have started for \$3,000 or less.
 - C. Maiden over the age of five (5) must have competed in pari-mutuel race within 18 months of the race.
 - D. Horses on the backside must be 2 years of age or older.
 - E. Trainers will be assigned stalls based on the number and conditions of the horses on his/her stall application. Any trainers that accommodate horses other than horses with papers in their file or that are not utilizing stalls assigned will be subject to having their number of stalls reduced or reassigned to other trainers at the discretion of the Racing Secretary.
4. **Trainers having a balanced stall application will be given preference.** The granting of stall space at Racetrack is for the purpose of assuring the availability of horses, **which in the sole opinion of management will produce the best racing meet.** Due to limited stall space, some requests will be denied. It is understood and agreed the granting and denial of stall space is at the sole discretion of the management of Racetrack.
5. **Stable Area:** A) No dogs will be permitted in the stable area. B) No smoking is permitted inside any enclosed barn or under shed rows in an open barn or any tack rooms. C) No sleeping or cooking is allowed in the tack rooms (Microwaves and coffee pots are allowed). D) Bagged sawdust, wood shavings, or wood chips are allowed (Management must approve any bulk and other bedding). All discarded bedding must be placed in proper areas provided. E) All hoses located in the Racetrack Stable Area must have an automatic shut-off nozzle and shall be turned off when not in use. F) Only biodegradable soap may be used. G) Management must approve any structures, stationary or temporary, prior to construction. H) The use of infrared heat lamps is prohibited. I) It is the sole responsibility of the trainers and their employees to maintain a clean and neat barn area. Stalls subject to inspection and if found unclean trainers will be subject to eviction. K) **TRAINERS VACATING STALLS PRIOR TO THE LAST SCHEDULED DAY OF THE MEETING (July 25, 2021) WILL BE CHARGED \$20 PER STALL FOR CLEANUP IF THE STALLS ARE LEFT DIRTY AND UNKEPT.**
6. **Miscellaneous:** The Applicant agrees to abide by and comply with all rules and regulations of the Oklahoma Horse Racing Commission and of Racetrack. Racetrack may televise or authorize or license the televising of horse racing conducted at Fair Meadows at Expo Square and accordingly, it hereby reserves television rights, whether in connection with any race, preparations therefore or ceremonies, or proceedings thereafter, or training at the track. This application is accepted on the condition that, if licensee's horse comes within range of the television camera, that licensee will sign and deliver to Racetrack releases permitting such television footage and the exhibition thereof. If stall space is granted, the Application, owner, or his/her trainer acting as agent of owner (when the application is signed by the trainer) or any other duly authorized agent acknowledges that the Applicant shall be licensee upon the ground of Racetrack and authorization granted for the stabling of horses shall be revocable at any time. Applicant acknowledges that Racetrack assumes no liability for loss by fire, any other acts of God or theft of any equipment or property of horsemen or any accident occurring on Racetrack premises. Owners and/or trainers will be held liable for any misuse of the stalls assigned to them for conduct of their employees on the grounds of Racetrack. By offer of this application, the owner and/or trainer agrees to indemnify and hold harmless Tulsa County Public Facilities Authority d/b/a Fair Meadows at Expo Square, its officers, agents and employees from any and all liability, claims, judgments, sum or money, legal fees, court cost, and investigation expenses, which may be incurred for or on behalf of Racetrack, its officers, agents or employees, in defense of any such liabilities or obligations, arising out of any act performed or committed by the Applicant, trainer, owner, their agents and/or animals. Any trainer that intends to bring a horse on grounds must have minimum worker's compensation on file with OHRC before doing so if they have employees.
